For this reason, our organization, systems and objectives have been adapted to the requirements of this environment, highlighting the quality, environmental and food safety system as one of the basic pillars that will lead GRUPO CONESA to business success.

In this spirit, GRUPO CONESA has defined and implemented a Quality, Food Safety and Environmental Management System, which meets the requirements of the UNE-EN-ISO 9001:2015, 14001:2015, BRC protocol, HALAL and KOSHER regulations and is structured and adapted for the specific manufacture of tomato concentrate (CONESA GROUP), tomato dices (CONESA BADAJOZ, AGRAZ, CONESA VEGAS ALTAS, CONESA PORTUGAL), tomato powder (AGRAZ and CONESA BADAJOZ), sauces (CONESA BADAJOZ and CONESA PORTUGAL), tomato fibers (AGRAZ) and peeled tomato (CONESA PORTUGAL).

In addition, aware of the need to ensure the manufacture according to the specified quality, safety, health, legality and authenticity of the products it manufactures, GRUPO CONESA is committed to the identification, evaluation and control of hazards related to food safety and therefore has defined and implemented a system of Hazard Analysis and Critical Control Points, in accordance with the provisions of the Applicable Regulations. Therefore it has been intended to integrate the HACCP in the quality and environmental management system defined by the ISO 9001:2015 and ISO 14001:2015 Standards. In this way we have tried to complement it from the point of view of safety. health and legality of the manufactured products and at the same time take advantage of the advantages of the Standard from the point of view of quality management.

The Management of GRUPO CONESA assumes its responsibility towards customers and recognizes that quality is "the ability to satisfy the needs of its customers, including those who are governed by the Halal and Kosher regulations" and that the achievement of this goal in a stable and lasting way is based on a set of systematic and planned tasks. Furthermore, it is to provide the basis for continuous improvement of the organization and is committed to meeting requirements other than those set by the customer and other interested parties, to complying with legal requirements and to continuously improving the effectiveness of the quality management system. To achieve this objective, this Quality and Food Safety System has been implemented, whose compliance is mandatory for all company personnel who direct, perform or verify any work that directly or indirectly affects quality, understood as defined above. Another objective pursued in the implementation of the system is a better performance / greater rationality in the activities related to quality. Management is committed to ensuring that the quality and food safety policy is disseminated to all areas related to quality, understood, implemented, reviewed and updated.

GRUPO CONESA, aware of the impact that its activities may have on the environment, establishes a commitment to environmental protection with the main purpose of minimizing its environmental impacts. The fulfillment of this commitment is a priority objective of the Management and all the employees of the factory, since GRUPO CONESA considers respect for the environment as a fundamental aspect of the pillar that sustains it.
